## Northeast Delta Dental Adds to Scholarship Fund Support

# Affordable Care Act Update

If at first you don't succeed, try, try again. And again, etc.

During the presidency of Barack Obama, congressional Republicans voted approximately sixty times to repeal Obama's signature legislation, the Affordable Care Act ("ACA"). While Obama was in office, these votes were largely symbolic, assured of a veto from the president even if they passed the Senate.

Since January of 2017, the presidency has been occupied by a man who campaigned on repealing the ACA and Republicans have maintained majorities in both houses of Congress. Yet initial attempts to repeal the ACA earlier this year faltered. But on May 4 Republicans in the House of Representatives overcame internal divisions to pass a revised version of their repeal and replace act, the American Health Care Act ("AHCA"), along party lines.

The bill will move on to the Senate, which is unlikely to take up the bill before it is scored by the Congressional Budget Office. Republicans enjoy a narrower majority in the Senate and some Senate Republicans, including Susan Collins of Maine, are already on record as opposed to prior versions of the bill. If the Senate passes a version of the AHCA, it is likely to differ from the version passed by the House and the two will have to be reconciled.

In relevant part, the AHCA as currently drafted:

- Replaces the individual mandate with a 30 percent surcharge on premiums for those who experience a gap in coverage;
- Allows states to opt out of certain provisions of the ACA, including one that requires insurers to provide a minimum set of health benefits;
- Delays the imposition of the "Cadillac Tax" until 2025; and
- Caps Medicaid payments to states by allotting states a per capita figure or giving states block grants with few conditions.

The implications of these changes for dental insurance and for Northern New England are unclear. Stand-alone dental insurance was never subject to the ACA's individual mandate. While dental insurance's exemption from the "Cadillac Tax" had been seen as a marketing advantage for employers, its implementation has already been delayed without a significant detriment to stand-alone dental plans. It is possible that some states may opt out of requiring pediatric dental coverage as an essential health benefit. But since health plans can satisfy the pediatric dental requirement if the benefit is offered independently, such an opt-out is also unlikely to affect stand-alone dental plans.

Unless and until the AHCA passes and states in our region take action in response, Northeast Delta Dental will continue to offer dental plans to individuals both on and off ACA exchanges. Most of Northeast Delta Dental's business comes from employer groups and as long as employers see the benefit in offering dental insurance, replacement of the ACA should not affect Northeast Delta Dental significantly.

Where changes could affect Northeast Delta Dental are in the less publicized area of federal regulations. The ACA spawned hundreds of new federal regulations and the new administration has shown an interest in repealing some administrative rules or limiting the creation of new rules. Changes to or changes in enforcement of administrative rules could affect dental insurance even without congressional action.

## Exciting News about Electronic Funds Transfer and Electronic Remittance Advices!

For those dental offices which are currently receiving payment (Electronic Funds Transfer) and remittance notices (Electronic Remittance Advices) electronically, we are pleased to announce that you will soon have access to all your Delta Dental patients' ERAs in one location, **regardless of which Delta Dental Member Company provides the coverage**. You will also begin to receive EFT payments directly from the Delta Dental Member Company which processed the claim.

Some important points:

**As of July 1, 2017**, Northeast Delta Dental will no longer use Change Healthcare for EFT payments or ERAs and will begin to use DentalXChange.

For those **who are currently receiving** EFT payments and ERAs from Northeast Delta Dental through Change Healthcare:

- To continue to receive electronic payments for all your Northeast Delta Dental patients, and for all your patients covered by other Delta Dental Member Companies, you will need to sign up for electronic fund payments (EFT) **directly with Northeast Delta Dental**. We will contact you soon to provide additional information to help you make the transition to this new process.
- If you choose **not** to sign up with Northeast Delta Dental directly and are currently receiving EFT payments from us or other Delta Dental Member Companies, please be aware your electronic checks and remittance advices currently being provided (including those by Northeast Delta Dental via Change Healthcare) will instead be generated on paper and mailed to you in the near future.

For those who are **not** currently receiving EFT payments and ERAs from Northeast Delta Dental through Change Healthcare:

- Please contact Provider Services at 1-800-537-1715, extension 1100 if you are interested in initiating EFT payments and ERAs.
- After you sign up directly with Northeast Delta Dental to receive EFT payments, you will be able to view

and print copies of your Delta Dental ERAs online or download them into your practice management system by logging into a website provided by Delta Dental.

- To have the ERAs automatically downloaded into your practice management system, your practice management system will need to be compatible with DentalXChange. You will also need to initiate an agreement with DentalXChange. Your practice management system vendor should be able to help if there are any issues in this area.
