A message from Tom Raffio

Our values of communication, teamwork, quality and integrity are more than words-they are the core of who we are as people and how we operate as a business. Our success is exemplified in many ways-from growing our membership to over 1,055,000, to achieving a 99% customer retention rate, to garnering repeated recognition as one of the Best Companies to Work For, to creating impact on oral health through our philanthropic work. Northeast Delta Dental is thriving as a business and a community partner.

I am proud to share our 2023 annual report. I hope you enjoy a look back at our successes throughout the year. Unquestionably, the implementation of dental care benefits for New Hampshire adult Medicaid recipients in April was profoundly important to me. After 25 years of advocacy, we proved that persistence pays off, resulting in over 90,000 adult Medicaid recipients being afforded coverage for oral health care. But we know this is a race without a finish line. Now, we have turned our focus to building a network of providers that adequately meets the needs of our community. I have taken a personal interest in this effort and remain committed to ensuring care is available to all who need it.

A key part of ensuring the availability of care is addressing the workforce challenges experienced by our providers in northern New England. Last year, Northeast Delta Dental made a three-year, \$6 million commitment to student debt repayment awards. In 2023 over \$1.3 million of that contribution funded sixteen dental loan repayment awards in Maine, New Hampshire and Vermont with the goal to attract more dentists to the region. More funding will follow in the coming year. This is just one of the impactful ways our team is furthering our mission, and you'll read about several others in the following pages.

Another important example of living our values is continued support for veterans across the tri-state region. Through our ongoing financial contributions, we are providing a vital safety net of funds for not-for-profit organizations in Maine, New Hampshire and Vermont to support veterans who otherwise are not eligible to get the oral health care they need. Our Foundation and corporate giving contribute to a broad range of programs including oral health services, women empowerment events, initiatives to end homelessness and food insecurity, disease research and the arts.

I also want to express my sincere gratitude for being named this year's Garden Party Honoree by The Moore Center. Their mission of "creating opportunities for a good life" for people with intellectual, developmental and personal challenges inspires me in my work to improve our community's overall health by increasing access to oral health care. The reason is simple: everyone deserves a healthy smile.

Thank you for helping Northeast Delta Dental live our values and enabling us to advance our work to improve health, wellness and quality of life for people across the tri-state region.

Turning talk into action across our communities

WE ARE PLEASED TO REPORT THAT 2023 WAS ANOTHER SUCCESSFUL YEAR FOR DELTA DENTAL PLANS OF MAINE, NEW HAMPSHIRE AND VERMONT.

Each of our companies realized a net gain in primary members, with Maine adding 21,179 members, New Hampshire 11,465 members and Vermont 8,974 members. While there is much to celebrate in these positive business results we are just as proud of how our organizations continue leveraging our financial successes to fulfill our company mission and values. The following summaries highlight just some of the ways we exemplify the finest in communication, teamwork, quality and integrity across the tri-state region.

Living our values in Maine

Our ongoing financial support for the University of Maine at Augusta (UMA) will enable the expansion of the current UMA Lewiston Center Dental Clinic and increase enrollment of dental assisting and expanded functions dental assisting students. Additionally, we supported our veterans in Maine with a \$200,000 grant to the Maine Veterans' Dental Network (MVDN), which enables Maine's veterans to get the oral health care they need. New York University's College of Dentistry once again offered services to dental patients in rural Maine thanks to Foundation funding. Lastly, our partnerships throughout Maine continue to enable us to support age-one oral health care through vital programs.

Living our values in New Hampshire

Our New Hampshire team is supporting the pilot of a program named My Smile Buddy, similar to the one in Maine, which raises awareness and enables more proactive treatment of caries in young children. We presented four Federally Qualified Health Centers (FQHCs) with a check for \$500,000 to continue the impactful work they are doing in the community. In an annual celebration of teamwork, our sponsorship of the Delta Dental Mount Washington Road Race raised funds for Coös County Family Health Services, which provides health care, social services and dental care to the rural residents of northern New Hampshire. We are also proud of our work supporting New Hampshire veterans with the financial assistance and connections to access dental care they might otherwise forego. Additionally, we highlight the excellent work of the Northeast Delta Dental Foundation. Through grant funding, Greater Seacoast Community Health is able

to help people struggling to afford or access care in Somersworth and Portsmouth area communities with its dental care programs. Finally, Northeast Delta Dental partnered with DentaQuest and Solvere to arrange mobile dental units throughout New Hampshire to increase access to dental care to those newly eligible for the adult Medicaid dental benefit.

Living our values in Vermont

We are proud that our organization is helping bring more dentists to Vermont by offsetting their expenses with dental loan repayment programs, scholarships and grants. In Vermont, we also supported our veterans with the initial funding of a new program through which not-for-profit dental clinics and Federally Qualified Health Centers will provide dental services to qualifying veterans. Another valued program in Vermont, the Vermont Head Start Association's Tooth Tutor program, received a grant to help Tooth Tutors (registered dental hygienists) reach more children and families with education and dental care to improve their oral health. A Foundation grant is helping Windham County Dental Center provide accessible and affordable oral health care for uninsured and Medicaid patients across 23 Vermont towns. Notably, the Dental Center reaches patients in need who represent diverse populations, informing them of available services to improve their oral health and overall well-being in a supportive, respectful, and compassionate environment.

Building connections through communication

Adult Medicaid coverage comes to New Hampshire

After 25 years of advocacy we are proud that dental care coverage has been extended to adult Medicaid recipients in New Hampshire. With the passage of that landmark legislation, we started spreading the word—and the smiles.

To support the roll-out of Medicaid coverage, which started April 1, 2023, Northeast Delta Dental and its partners, DentaQuest and Solvere Health, held mobile dental clinics exclusively for Medicaid recipients ages 21 and older with multiple stops across New Hampshire throughout the year. Additionally, we continue to actively encourage participating dentists in New Hampshire and the surrounding areas to become Medicaid providers, especially providers who have already been serving children with Medicaid benefits and those outside our network who are dedicated to serving Medicaid patients in their community.

Reaching more families with early-childhood dental care

Our communication initiatives and efforts to live our values extend across the tri-state region. In all three states we are focusing on the early childhood disease caries—typically a behavioral and nutritional disease that is entirely preventable. Central to our effort is supporting programs that instruct a wide range of health care workers on how to treat infants and toddlers for caries and help young parents recognize the need for year-one exams.

In Maine, we are working with several local organizations to expand training in age-one oral health care. The Justice and Equity Dental Initiative (JEDI) - Age One Dental Program includes both instructional and clinical training for dental students, dental hygiene students, medical students, pediatricians, and their ancillary staff. To date, more than 190 children have been seen for screenings and preventive care. This includes home care instruction and nutritional counseling for the parent or guardian, application of fluoride, and referral to a dental home for any needed restorative follow-up care.

In New Hampshire, we support the Nashua Department of Health and Human Services and Columbia University on piloting a similar program—My Smile Buddy—designed to enhance recognition among Community Health Workers in the etiology of caries and in anti-caries strategies for young families. The program is delivered in the community member's native language and is culturally sensitive to the diet and norms of the culture.

Once the pilot has concluded in Nashua, it may be replicated in Vermont as part of the state's plan to deliver early childhood caries mitigation training.

Northeast Delta Dental is partnering with dental professionals and community healthcare groups to launch anti-caries educational and preventive programs for infants, young children and their parents.

Through our funding programs with UMA, Northeast Delta Dental is helping to fill the gap in dental services across Maine.

Addressing workforce challenges in the dental industry across northern New England

To address the workforce challenges being faced by our providers in northern New England we contributed \$665,000 to the University of Maine at Augusta (UMA) to expand its Lewiston Center Dental Clinic. This will allow increased enrollment of dental assisting and expanded functions dental assisting students, as well as provide dental hygiene students with another location for clinical rotations.

We also help dentists with student loan repayment awards, including incentives to stay and practice in northern New England. In 2023, we funded 16 dental loan repayment awards in Maine, New Hampshire and Vermont, totaling over \$1.3 million. These funds came from Northeast Delta Dental's \$6 million contribution in 2022, administered by the Recruitment Center at Bi-State Primary Care Association (Bi-State) and awarded to dentists in northern New England over three years.

Running for a cause to the top of Mount Washington

Few activities exemplify teamwork better than sports, and through sports Northeast Delta Dental works to further our mission. In 2023, we supported the 62nd running of the Delta Dental Mount Washington Road Race, which raised \$62,000 for Coös County Family Health Services, to support their work providing vitally needed dental care to the rural residents of northern New Hampshire.

We also have a long-running partnership with the New Hampshire Fisher Cats baseball organization, presenting the 2023 Oral Health Challenge to children 12 or younger. Children who compete in the Challenge document they have brushed twice and flossed once daily for seven consecutive days, earning them two free tickets to one of four NH Fisher Cats games. The Portland Sea Dogs also teamed up with us for a special Tooth Fairy event at each home game, where one lucky child had the opportunity to wear tooth fairy wings and brush the bases with an oversized toothbrush.

Driving excellence in serving our members

In 2023, we reached over 1,055,000 members thanks to the professionalism of our employees and broker partners. Additionally, we are proud that 86% of dentists in Maine, New Hampshire and Vermont are in our network.

It also speaks volumes that of the two million-plus local claims processed in 2023, our team processes each in an average of 1.24 days. Moreover, when someone calls to speak with a live customer service representative, they get through in just 30 seconds on average. This commitment to excellence has resulted in a 99% customer retention rate and a 92% member satisfaction rating.

Promoting quality dental care at home

Northeast Delta Dental continues to promote quality dental care throughout our network and communities. Health *through* Oral Wellness[®], or HOW[®], is our unique, patient-centered oral health program which promotes good oral and overall health. In 2023, we partnered with PreViser[®] and Philips on a new feature for qualified members, the HOW[®] Home Care Offer, designed to help keep members on the path toward healthier lives.

Members who have HOW® as part of their dental benefit already receive free, customized oral health tips designed around their specific oral health needs. Now, through the HOW® Home Care Offer, qualified members can purchase Philips Sonicare products, including an electric toothbrush, at a significant discount. Because using an electric toothbrush makes it easier to brush more consistently and access hard-to-reach places, we are confident this new feature of HOW® will help improve the quality of home dental care and spread more smiles across our communities.

Enabling the underserved to get the oral health care they need

In 2023, we awarded a \$200,000 grant to Maine Veterans' Dental Network (MVDN) to provide a vital safety net of funds to support Maine's veterans who otherwise are not eligible to get the oral health care they need. Through the MVDN, dental services are provided by a network of 22 not-for-profit dental clinics, Federally Qualified Health Centers (FQHCs) and Maine dental teaching schools. Additionally, we invested \$200,000 to fund an informal program in New Hampshire that connects each qualifying veteran with a dental office where care is provided. In Vermont, we've recently received support to create a program similar to the MVDN, beginning with a \$100,000 commitment to recruit not-for-profit dental clinics and FQHCs into the program.

Significantly, our Foundation and corporate giving programs assisted many other populations facing economic hardship. A \$45,000 grant was awarded to Vermont Head Start/Early Head Start programs to support the Vermont Head Start Association's Tooth Tutor program. Head Start registered dental hygienists work with low-income families to help improve oral health outcomes for their children. This work includes locating dental homes for children, providing oral health activities and education that help children become comfortable going to the dentist, and working with local dental practices in their treatment of Head Start children.

Supporting more equitable opportunities for diverse populations

For integrity to permeate an organization, it must be modeled at the top. Northeast Delta Dental President & CEO Tom Raffio continues to exemplify this point. In 2023 Tom was recognized as The Moore Center's Annual Garden Party Honoree for his numerous contributions to the greater Manchester, New Hampshire community, both personally and professionally, that further the organization's mission to serve people with intellectual, developmental and personal challenges while helping them create opportunities for a good life.

In line with Tom's example, doing the right thing for our employees and our community extends across a broad range of initiatives, from increasing access to oral health services in northern New England, to supporting youth services, disease research, prevention programs to end homelessness and food insecurity, as well as culture and the arts. It's all part of our mission to improve health, wellness and quality of life for people across the tri-state region.

To carry out this mission with integrity, we provide ongoing employee training on various topics to help us recognize where inequities may exist and ensure our initiatives promote acceptance and inclusion.

We are also committed to ensuring our website meets national accessibility standards. Sensitive to the range of needs our members may have when visiting our site, we added features to improve navigation and enhance search functionality, along with customized sections to better serve every one of our members.

Spreading more smiles through our Foundation

THE NORTHEAST DELTA DENTAL FOUNDATION PROVIDES A VITAL FINANCIAL ENGINE FOR LIVING OUR VALUES THROUGH PHILANTHROPY.

In 2023, our Foundation awarded grants totaling \$1,335,104.81 to 62 oral health programs, including \$592,659.95 in Maine, \$559,558.86 in New Hampshire and \$182,886 in Vermont. These funds go to organizations and initiatives in the three states that provide oral health education and dental care to uninsured and underserved communities.

Bringing vital oral health services to children in rural Maine

Thanks to a \$50,000 Foundation grant, New York University (NYU) College of Dentistry returned to Machias, Maine, to conduct its 14th NYU College of Dentistry's Global Student Outreach Program, which provides vital oral health services to children in rural Maine. In particular, Washington County residents have historically faced profound barriers in gaining access to affordable, quality oral health services. These barriers include poverty, lack of dental insurance, high-cost co-pays and limited access to dentists.

Better supporting the underserved in New Hampshire

In New Hampshire, our Foundation awarded \$5,000 to The PLUS Company to offer dental health education to the over 400 adult clients with disabilities. Adults with disabilities often encounter many health challenges, not the least of which is with their oral health. Research has shown that this population encounters more barriers in maintaining recommended oral health routines and tends to have a higher percentage of disparity in meeting their oral health needs. This program reinforces the importance of good oral health.

Helping at-risk patients connect to services in Vermont

Through their grant-funded outreach efforts, Battenkill Valley Health Center (BVHC), has helped to reduce dental fear, provided oral health education, and connected people with a dental home.

Driving excellence in serving our members

In 2023, Northeast Delta Dental supported hundreds of organizations with over \$1,500,000 in contributions to non-oral health initiatives. These ranged greatly in size and substance.

In Maine, we co-sponsored the 19th annual Cares for Kids Radiothon in support of The Barbara Bush Children's Hospital. The Barbara Bush Children's Hospital at Maine Medical Center is one of the country's leading children's hospitals, committed to enhancing the lives of children through excellence in patient care, research and education.

The Cares for Kids Radiothon in Maine raised over \$500,000 for The Barbara Bush Children's Hospital.
