## About Us

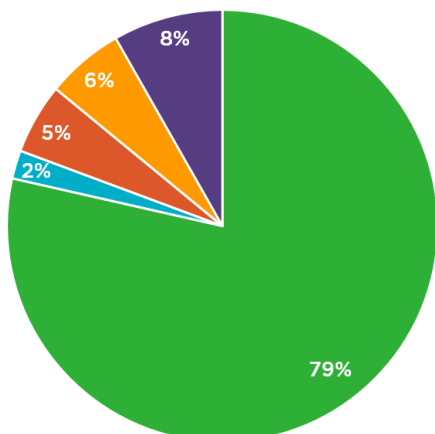

Our GOSE<sup>SM</sup> program is backed by a cash refund policy that guarantees seven major areas of service.
